Engineer Report – The written engineer’s report is attached and is a part of these minutes.

The pump that has been pulled from the Meadow Run pump station needs to be repaired or replaced. Mr. Polistina is investigating whether or not smaller pumps can be utilized in that station and the bad pump replaced with a smaller, less expensive pump.

Bids will be received on March 10th for the Washington Avenue project. It appears that the project will be completed with funds from the Environmental Infrastructure Trust.

Engineering Projects

1. **Emergency Maintenance Contract**

There was no work completed by Kline Construction within the last month. No billing is due at this time.

2. **ACUA Contract Administration**

The maintenance logs from the ACUA during the past month have been normal overall. The new pumps were installed at the Cardiff station last month. There are currently four stations operating with a single pump. The pump removed from the Lyons Court station was sent to Willier and we have approved the repair quote in the amount of \$1,775.00. The pump is expected to return to service within the next two weeks.

Meadow Run is operating on a single pump due to a pump failure. We have received a repair quote in the amount of \$7,567.00 from Willier. The cost of a replacement unit ranged between \$13,000 to \$15,000. Based on the operating conditions at the station the existing pumps may be oversized so we plan on verifying the existing flows to determine if a smaller pump could be utilized. The existing pump is 40 HP.

The Fernwood station has only a single pump, with pump number one being recently removed due to failure. It was sent to Willier and we are waiting the repair quote.

We are waiting for the ACUA to complete the replacement of the seals for pump # 2 at the Trailer Park station, but the pump can be used if an emergency developed.

3. **Wet Well Cleaning Contract Administration**

Caprioni Family Septic completed the normal monthly basket and wet well cleaning over the past month. They also completed the preventative maintenance jetting at several areas identified by the Authority Operator.

We have recommended a payment in the amount of \$9,913.00 from the Operating Account for the work completed in January.

4. **Spills**

There were no spill incidents within the last month.

5. **FAA Pump Station Upgrades**

All of the comments from the Pinelands Commission have been addressed. Once we receive Pinelands approval we will be submitting an application to obtain an Amended Treatment Works Approval for the new station.

6. **Miami Pump Station Elimination**

We are currently working on preparing the design plans and verifying the location of the other utilities.

7. **Reega Reserves Video Inspection**

The contractor for the project has been progressing but due to the extreme cold temperatures work has been delayed. We expected all work to be completed by early March.

8. **Lakeside Force Main Location**

We had utilized the Authority contractor, Kline Construction, to help verify the actual location of the force main from the Lakeside pump station. The work was originally completed last summer and there were some areas where they were unable to access due to heavy vegetative growth. With the trees now bare we had Kline locate the force main in these areas.

A survey of the force main will be completed and we will prepare a proper easement document.

9. **Washington Avenue Interceptor Rehabilitation**

Our office received the Authorization to Advertise from the NJDEP. We have advertised the project and expect to receive bids on March 10th. All of the received bids must be reviewed by the NJDEP prior to the Authority awarding the contract. We expect the project to be awarded at the April monthly meeting.

10. Manhole Rehabilitation

With the help of the Authority Licensed Operator we have identified twelve manholes in need of repair. Half of the manholes are located in West Atlantic City with the remaining manholes located throughout the Township. We have prepared bid plans and specifications and expect to receive bids in March.
