**Engineer's Report**

**Engineering Projects**

**1. Emergency Maintenance Contract**

Kline Construction completed two items within the last month. They repaired the bypass adapter for the force main at the Miami Pump Station. Kline also installed three concrete bollards at the Whitewater pump station to protect the gas service and meter.

We have recommended payment in the amount of \$3,977.06 from the Operating Account for the work completed.

Kline Construction also completed the installation of a new sanitary lateral at 455 Zion Road for the newly constructed Dollar General.

We have recommended payment in the amount of \$7,423.73 from the Developing Account for the work completed.

**2. ACUA Contract Administration**

The maintenance logs from the ACUA have been normal over the past month. The Beaver station has been operating with a single pump due to the deteriorated condition of one of the pumps. The repaired pump for the Storybook station has been received and returned to service.

**3. Wet Well Cleaning Contract Administration**

Caprioni Family Septic completed the normally scheduled basket and wet well cleanings this past month. They also completed preventative maintenance jetting in the normal areas selected by the Authority Operator throughout Egg Harbor Township and the City of Linwood.

Caprioni also assisted Kline with the repair of the bypass adapter at the Miami station and provided emergency jetting along Laquinta Drive.

We have recommended a payment in the amount of \$11,131.50 from the Operating Account for the work completed in February.

4. Spills

There were no spill incidents within the last month.

5. Trailer Park Pump Station Replacement

A pre-construction meeting was held earlier this month with the contractor, Kline Construction. The project is anticipated to begin the beginning of May and take approximately one month to complete.

Kline will be forwarding submittals for approval within the next week.

6. Gravesmith Drive Sanitary Sewer Extension

The Authority will receive bids for this project on March 21st. We will provide a report of bids during the meeting.

Our office was attempting to expedite the installation of a doghouse manhole in Washington to alleviate any conflicts with the County resurfacing of Washington Avenue, but due to the pricing provided we determined it was best to include that scope of work with the overall extension project.

7. 2018 Video Inspection & Main Cleaning

A pre-construction meeting was held earlier this month with the contractor, Mobile Dredging and Video Pipe.

Mobile Dredging and Video Pipe anticipates beginning work this week pending inclement weather.

8. Miami Pump Station Elimination

The updated CAFRA and TWA applications have been sent to the NJDEP.

9. Beaver Pump Station Upgrades

Our office is preparing the plans and specifications for the replacement of the pumps and other interior components of the wet well due to their deteriorated condition.
