Engineering Projects

1. Emergency Maintenance Contract

Kline Construction completed several miscellaneous items over the past month. They replaced two damaged manhole castings and reset an existing casting along Washington Avenue, within the section the County will be repaving later this summer. Kline provided materials to stabilize the parking areas along the front of Crystal Lakes and English Mill pumping stations. They also added some to address a low area within the Mountain Lane station.

Included with this month's billing is the installation of the new cleanouts for 204 and 206 Lyons Court.

We have recommended payment in the amount of \$12,843.98 from the Operating Account for the work completed.

2. ACUA Contract Administration

The maintenance logs from the ACUA have been normal the past month. The Beaver station is the only location operating with a single pump. Due to the condition of the pumps, a replacement impeller was ordered for the one functioning pump to keep the station operational until the upgrade can be completed. The cost of the impeller was \$3,000.00.

All of the remaining stations are operating satisfactorily.

3. Wet Well Cleaning Contract Administration

Caprioni Family Septic completed the normally scheduled basket and wet well cleanings this past month.

We have recommended a payment in the amount of \$10,614.00 from the Operating Account for the work completed in April.

4. Spills

There were no spill incidents within the last month.

5. Trailer Park Pump Station Replacement

All of the project submittals have been reviewed and approved by our office. Kline should have the required road opening permits within the next week. We anticipate construction of the new wet well will begin later this month once the concrete structure has been delivered.

The relocation of the electrical service will be completed next week by Atlantic City Electric.

6. Gravesmith Drive Sanitary Sewer Extension

The contractor, Crown Pipeline, began construction last week with the installation of the doghouse manhole in Washington Avenue. They have continued with main installation along Gravesmith Drive. We expect the work to take approximately 3-4 weeks.

Our office has contacted all of the resident's on Gravesmith to verify the location for each lateral connection.

7. 2018 Video Inspection & Main Cleaning

The contractor suffered several equipment issues over the past month, so they were unable to complete the project within the required time frame. We have provided them an additional two weeks to get of the remaining mains cleaned and inspected. All work is expected to be completed by the end of the month.

We have recommended a payment in the amount of \$19,344.95 for the work completed.

8. Beaver Pump Station Upgrades

Our office is finalizing the plans and specifications for the upgrades at the Beaver station. We anticipate we will received bids prior to the June meeting.

9. Delilah Pump Station Guide Rails

Our office solicited for informal quotes for the replacement of the guide rails at the Delilah station. A report will be provided at the meeting.
