Vincent Polistina, Engineer, John Ridgway, Solicitor and Elaine Super, Authority Clerk were also in attendance. Mr. Duffy called and advised that he may be late.

General Public Discussion

There was no one present from the public, therefore a motion was made by Mr. Schwemm, seconded by Mrs. Prendergast to close the public portion of the meeting. All voted yes.

Engineer Report – The written engineer’s report is attached and is a part of these minutes.

~ Resolution #86 – 2015 [Contract #85]

Motion Mrs. Prendergast, seconded by Mr. Pfrommer to award the Brookside Odor Control Contract to TKT Construction in the amount of \$44,599.00. All voted yes.

Mr. Ridgway advised the commissioners of the FAA Agreement, which is still in need of a detailed review. There are too many issues within the agreement, including unknown environmental regulations.

5:45 PM – Connection Fee Rate Hearing ~ Resolution #85 – 2015

Based on 2015 flows and previous debt service and expenses, the 2016 Connection Fee will decrease to \$1,737.00 per Equivalent Dwelling Unit. Motion Mr. Schwemm, second Mr. Pfrommer to adopt this rate effective January 1, 2016. All voted yes.

Engineering Projects

1. **Emergency Maintenance Contract**

Kline Construction completed work at several locations over the past month. They repaired a cleanout at 25 White Oak Lane and adjusted a manhole casting located on Bay Drive due to the Township's retaining wall and gabion project. We also had Kline attempt to identify and locate the laterals for the businesses still in operation that are serviced by the former Miami Pump Station.

We have recommended a payment in the amount of \$4,917.75 from the Operating Account for the work completed.

Kline Construction completed the installation of a new lateral for 326 Seapine Avenue and capped the existing service that was located within the driveway.

We have recommended a payment in the amount of \$3,611.37 from the Developer Account for the work completed.

2. **ACUA Contract Administration**

The maintenance logs from the ACUA have been normal over the past month. The West Jersey station is currently operating with a single pump. One pump was removed at the end of last month and was sent for service. It is still covered by the original warranty, so it has been sent back to the manufacturer.

An emergency situation occurred at the West Jersey last Friday evening when the remaining pump failed and would not operate. The ACUA was able to modify one of the spare pumps and maintain operation of the station. The failed pump has also been sent out for repair.

The Ocean Heights station continues to operate with a single pump pending the completion of the station upgrades in January.

The controller at the Beaver station was replaced last month by the ACUA. During recent work at the station the old unit failed and was not repairable.

3. **Wet Well Cleaning Contract Administration**

Caprioni Family Septic completed the normally scheduled basket and wet well cleaning over the past month. They replaced the hooks on the trash basket cables at the Hingston and Storybook stations.

Caprioni completed preventative maintenance jetting in several areas selected by the Authority Operator.

We have recommended a payment in the amount of \$9,191.72 from the Operating Account for the work completed in November.

4. **Spills**

There were no spill incidents within the last month.

5. **Washington Avenue Interceptor Rehabilitation**

The contractor began the application of the epoxy coating earlier this week. All work should be completed by the end of the week. This will finalize the project.

No payments are due at this time.

6. **Fire & Mill Road Construction**

Prior to the County completing the final paving to Fire Road, we completed a survey of the common force main from the New Jersey American Water building to the tie-in location, across from Weinstein Supply.

A updated as-built will be created and incorporated in the Authority GIS system.

7. **Brookside Odor Control**

The Authority received bids for this project on December 16th. We will provide a report of the bids during the meeting.

8. **Ocean Heights Pump Station Upgrades**

The contractor is in the process of ordering the new pumps and control panels. Installation is expected to begin in early February.

9. **FEMA HMGP Generator Program**

Our office is preparing the site plans and bid specifications for the generator project. We expect to have generator units selected by the end of the month.

10. **IBM Basin Video Inspection**

We have begun to develop the plans for the completion of the jetting and video inspection of all the sanitary mains that are located within the IBM sanitary basin.

11. **Trailer Park Pump Station Replacement**

We have started the design work for the replacement of the existing station facilities.

The application is for the conversion of office space into several classrooms and playroom for the proposed day care.
