

## Egg Harbor Township Recreation Commission

### July 16, 2014 Minutes

Attendees: Fairfield, Davis, Gallagher, Hiller, Lincoln, McComb, Messina, Rispoli (late 730pm) and Warrell. (Fiedor excused absence).

1. Minutes:

May 14 and 21, 2014 were approved by a vote of 7-0.

2. Public:

Football Camp-

Tyler Capille requested use of a Veteran's Memorial Park football field for a tutorial football camp for future high school players. He was advised that this camp must be run through and in conjunction with EHTYO Football. It was approved by a vote of 7-0.

3. Old Business:

Travel Basketball-

Cameron Bell addressed the Commission. He advised that Travel Basketball will hold tryouts in October. He indicated that a request for the EHT school gyms, at Fernwood and Alder, have been submitted to the Board of Education. He asked whether a decision has been made regarding Travel playing games at the Community Center. Director Lincoln advised that he does not foresee the EHT Recreation Department dropping the program. Final determination of gym use will be completed by his predecessor. Director Lincoln indicated that the Community Center needs to be staffed on Saturdays and Sundays for these games.

Cameron asked whether food items may be sold during the games. Director Lincoln stated that food items must remain in the multi-purpose room only. Absolutely no food or drink, other than water may be taken into the gym. Cameron understood and agreed. He inquired about fundraisers and how the funds should be dispersed. Vice-Chair Davis advised that the Travel Program must take care of all internal problems. By-laws need to be reviewed by the Recreation Commissioners. A copy was provided.

4. Use of Facilities:

EHT Teachers-

Request to use the Canale Park Amphitheater on 7/19/14 for a movie was approved via email 4-2.

Applebee's-

Request to use of the Baseball field at Bargaintown Park, on July 20, 2014, was denied by a vote of 0-8.

United Filipino Community Movement-

Request to use the Amphitheater and Tennis Court at Canale Park, on August 2, 2014, was approved by a vote of 8-0.

EHT High School Key Club-

Request to use Tony Canale Park Amphitheater, on August 13, 2014, was denied by a vote of 1-7.

Tradition Lacrosse-

Request to use a Veteran's Park Lacrosse field, on 7/7, 7/14, 7/28, 8/4, 8/11 and 8/18, was denied by a vote of 0-8.

5. New Business:

Recreation Commissioners-

Davis (5/18/19), Messina (5/18/19) and Warrell (5/18/16) were re-appointed.

EHTYS-

2014 Financial report needs to be reviewed. It shows Total Expenditures (\$54,403.79) exceeding Total Revenue (\$42,338.61). Commissioner Gallagher will bring this to the attention of the EHTYS Board at their next meeting.
