# **JULY 17, 2013 MINUTES**

## 1. Minutes:

June 19, 2013 minutes were approved 9-0. (Fairfield motioned and Messina seconded the motion).

# 2. Old Business:

## **EHTYS By-Laws-**

Commissioner Messina will review the by-laws and identify areas that need to be addressed. The redefined by-laws will be emailed to the Recreation Commissioners for their review and input. All Commissioners are to bring the by-laws to the August 21, 2013 meeting for further review and discussion.

## **EHT-BMX Security System proposal-**

Three quotes must be submitted for the security system. Quote from PRO Video has been received. Vice Chair Davis will review the bids.

### **Atlantic Shore Baseball-**

The All Star team comprised of players from EHT, Galloway and Mays Landing moved their practices to another location other than EHT.

#### Veteran's Park Fieldhouse-

Work on the field house has not commenced due to JIF insurance. Once the money is received the work can begin.

### 3. Use of Facility Requests:

### **Shore Fellowship Church-**

Request to use the Amphitheater at Tony Canale Park, on August 18, 2013, for a movie night, was approved 9-0. (Gallagher motioned and Messina seconded the motion).

### **EHT Key Club**-

Request to use the Amphitheater, Tennis and Volleyball courts at Tony Canale Park, on August 15, 2013, for their annual Kick Off party, was approved 9-0. (Warrell motioned and Fiedor seconded the motion).

#### NJIBL-

Request to use the Baseball field at Bargaintown Park on Wednesdays and Sundays, from August 28-November 17, 2013, was conditionally approved by a vote of 9-0. (Fiedor Motioned and Hiller seconded the motion).

EHTBO must be contacted to determine field availability. A roster, schedule and insurance must be provided to the Recreation Department.

#### 4. New Business:

#### **EHT Board of Education-**

Chairman Fairfield and Recreation Director Lincoln met with the EHT Board of Education. A list of recognized EHT Recreation Organizations was presented. The list included EHTYO which had been previously omitted, by the Board of Education. A request was made to place all of the EHT Recreation endorsed organizations in the number 2 category. However, the Board of Education advised that consideration for the category change will not be entertained at this time. They voted to amend their "Pay to Play" policy for the EHT students. Refunds will be provided to those that have already paid the fee. In the future, the EHT Board of Education will review the Recreation Commission's request. As for now, EHT Recreation Organizations will remain in category 3. Vice Chair Davis suggested EHT Recreation Organizations requesting "Use of Facility Requests" for school use go through the Recreation Department. The individual groups will fill out the form and take it to Recreation. The form will be reviewed and submitted to the EHT School District by the Recreation Department.

#### **Recreation Commission meeting-**

The August meeting was changed from August 14 to August 21, 2013. Notice will be posted in all applicable areas. (Gallagher motioned and Fiedor seconded the motion).

#### 5. Public:

# **EHT Wrestling-**

Greg Dix stated that Wrestling had submitted their Use of Facility for Tuesday, Wednesday and Thursday for the 2013-2014 season. He inquired whether a decision had been reached. An affirmative response was provided. Wrestling will use the Auxiliary Gym on Tuesdays and Thursdays, and the Multi-purpose room on

Wednesdays. The only time they won't be able to use the multi-purpose room is when it is booked for another event on a Wednesday. Wrestling will be given advanced notice of such dates. The wrestling mats will need to be removed from the Auxiliary gym prior to the start of Karate and returned after Karate is finished. EHT Wrestling will be responsible to move the mats.
