

# EGG HARBOR TOWNSHIP RECREATION COMMISSION

## September 21, 2011 Minutes

Attendees: Fairfield, Fiedor, Gallagher, Hiller, Lincoln, Rispoli, Warrell and Williams.

1. Minutes: August 17, 2011 minutes were approved 6-0 with 1 abstention.

2. Presentation/Public:

- Glory Day Sports:

Matt DeNafo and Jamie Connor requested permission to use EHT Recreation fields for Adult Sporting Leagues. Which include, but are not limited to, Co-ed Flag Football, Men's Flag Football, Kickball, Softball, and Field Hockey. They requested use of fields/facilities that were not currently being used for local recreational organizations. Time requested during the week was 7-10pm and all day Saturday and Sunday.

Their programs run during all four seasons. Fall beginning in September, Winter beginning in December, Spring beginning in April, and, Summer beginning in July.

Towns presently participating include Evesham Twp., Hammonton, Waterford Twp., Berlin, and, Camden County Parks. If approved, GDS would approach one season at a time.

EHT Recreation Organizations will be asked for a schedule of their field use.

This will determine whether this type of program is feasible. If so, a fee structure would have to be determined.

- EHTYO Baseball:

Ed Keil stated that general membership of EHTBO voted to have Recreational and Travel Baseball teams. By-laws were changed to include travel teams at the 9, 10, 11 and 12 year old programs. Various parents spoke on behalf of the program (Kevin Doine, Bob Baxter, Anthony Telvachico) indicating that they endorsed the change. Jamie Galispee was not in favor, as he felt it would hurt the recreation program.

3. Use of Facility:

High School Baseball

Lynette Buckley requested use of Bargaintown Park Baseball field for the High School team. To date no Use of Facility has been filed. Tabled.

EHTLA

Joseph Sheffer requested use of a field for a Fall Lacrosse League. Use of the back football field was approved, from 5-9pm on Tuesday and Thursday, and, 8am-12pm on Saturday and Sunday. However, it is an unlit field.

4. New Business:

EHT Soccer:

A sub-committee like Baseball, was formed for Soccer, by a vote of 7-0. Kathy Fiedor (Facilitator), Bob Williams and Toni-Lynn Rispoli will serve on this committee.

**EHT Recreation Organizations:**

A request of actual days, dates and times of every field use will be requested from each organization.

**5. Old Business:**

**2011 Capital Projects**

Four areas were submitted for use of the \$175,000.00 to Township Committee. It was determined that safety was paramount and ranking should be decided accordingly. They include Dugouts at Childs-Kirk Park, Lights on Field 5 for Football, Resurfacing of the Street Hockey courts and the conversion of Baseball's field 6 to a 50/70 field.
