Mayor McCullough called the meeting to Order at 5:05 p.m.

Meeting with Township Engineer Mott

Township Engineer Mott explained the area to be covered under the Community Development Block Grant –Phases 1 and 2 encompasses Woodrow, Elderberry, Douglas and Cypress Avenues off of Washington Avenue. Mr. Mott anticipates the Township will receive approximately \$100,000 in funding for improvements to these streets.

Old Business

Deputy Mayor Hodson inquired about the status of Betsey Scull Road which Engineer Mott advised is complete.

New Business

Block 2007, Lot 1

Administrator Miller explained Resolution 104 listed for consideration this evening authorizes Block 2007, Lot 1 to be dedicated as a public right of way for Lincoln Avenue. Dedication as a public right-of-way will allow South Jersey Gas Company access to make utility improvements on this property and eliminate the need for the Township to grant an easement.

Building height in flood zone (zoning height limit)

Administrator Miller said that following receipt of FEMA Advisory Maps, Construction Official Naticcihone is recommending the definition of building height be amended to require the vertical distance from grade to the top of the highest roof beams of a flat roof or the mean level of the highest gable or slope of a hip roof. Property located in any FEMA designated flood zone according to the current FEMA Advisory Flood Elevation maps will have its height measured from the Base Flood Elevation plus one foot (free board) for their respective zone. Revision to the current standards would eliminate the need for many residents to file for a Use Variance for height requirements.

Other Business (not listed on the Agenda)

Mayor McCullough questioned the status of street light outage reports which Administrator Miller stated have been forwarded to the Police Department.

Mayor McCullough requested the March 27, 2013 Township Committee Meeting be rescheduled to begin at 4:00 p.m. due to a conflict with a prior engagement. A resolution will be presented later in the evening.

Mayor McCullough stated Donna Burns is having difficulty moving forward with obtaining a lease with PAL for the Dog Park. Township Solicitor Friedman reported he provided a proposed lease between PAL and the Dog Park to the PAL Director for review and recommendation. The lease was returned by a representative of PAL with several recommendations including collection of rent from the Dog Park. Solicitor Friedman does not feel that is acceptable. Secondly, if PAL enters into a sub-lease, that would need to be approved by the Township and would also require the Township's lease with PAL to be amended. Administrator Miller suggested Township owned property in the vicinity of Broadway and West Jersey Avenues as a possible alternate location. Administrator Miller was instructed to arrange a meeting between the Police Department representative and the PAL organization in an attempt to resolve issues.

Administrator Miller reviewed add-on Ordinance 9 to amend Chapter 107, Explosives which will revise definitions and permits

requirements to address concerns of individuals who pack their own gun powder during hunting season. Ordinance 10 amends Chapter 225, Zoning to add a new subsection 225.49.1 entitled Affordable Housing Regional Growth Zone 12. Mr. Miller also explained that Ordinance 7, amending Ordinance 16-2012 revises the closing dated from December 31, 2012 to December 31, 2013. Administrator Miller advised there is an additional resolution for consideration to extend the 2012 Rotary Towing Licenses to March 31, 2013; Township Committee had no objection and will act on these matters later in the meeting.

Township Clerk Tedesco noted Resolution 102, awarding a professional service contract to Dr. Newkirk has been revised to Dr. Lauren Pagliughi, DMV. Dr. Newkirk was not available to provide his services at our annual Rabies Clinic as originally planned.

Administrator Miller announced a resolution will be presented at the next Township Committee Meeting to authorize the sale of a Plenary Retail Consumption License with Hotel/Motel Exception. The license will be sold by the public bidding option.

Ordinance No. 4

2013

AN ORDINANCE TO RESCIND ORDINANCE NO. 37 OF 2011 AND ORDINANCE NO. 22 OF 2012

WHEREAS, in 2008, the Legislature amended the Fair Housing Act ("FHA") with the Roberts Bill (P.L. 2008, Chapter 46) and thereby created "direct Mount Laurel responsibilities under the FHA" for state regional planning entities such as the Pinelands Commission; and

WHEREAS, specifically, the Roberts Bill included N.J.S.A. 52:27D-329.9(18) a, which provides as follows:

52:27D-329.9 Developments, certain, in certain regional planning entities.

18. a. Notwithstanding any rules of the council to the contrary, **for developments consisting of newly-constructed residential units located, or to be located, within the jurisdiction of any regional planning entity required to adopt a master plan or comprehensive management plan pursuant to statutory law, including the New Jersey Meadowlands Commission pursuant to subsection (i) of section 6 of P.L.1968, c.404 (C.13:17-6), the Pinelands Commission pursuant to section 7 of the "Pinelands Protection Act," P.L. 1979, c. 111 (C. 13:1 8A-8), the Fort Monmouth Economic Revitalization Planning Authority pursuant to section 5 of P.L.2006, c.16 (C.52:27I-5), or its successor, and the Highlands Water Protection and Planning Council pursuant to section 11 of P.L.2004, c.120 (C.13:20-11), but excluding joint planning boards formed pursuant to section 64 of P.L.1975, c.291 (C.40:55D-77), there shall be required to be reserved for occupancy by low or moderate income households at least 20 percent of the residential units constructed, to the extent this is economically feasible.**

[N.J.S.A. 52:27D-329.9(18)(a) (emphasis added)]; and

WHEREAS, since the adoption, and signing into law of the Roberts Bill on July 17, 2008, the Pinelands Commission has not amended its Comprehensive Management Plan ("CMP") to include the 20 percent affordable housing set-aside as required by the Bill, nor has the Council on Affordable Housing ("COAH") adopted any regulations implementing the required 20 percent affordable housing set-aside; and

WHEREAS, the Township's 2008 Housing Element and Fair Share Plan; which was adopted by the Township's Planning Board, endorsed by the Township Committee and submitted to the Court for review and approval in December of 2008; included the following component requiring a twenty percent (20%) affordable housing requirement in all new development within the Township's Pinelands Regional Growth Zone :

Pinelands Area Development - In accordance with N.J.S.A. 52:27D-329.9 Developments in certain regional planning entities at least 20% of the residential units shall be reserved for low or moderate income households within the Pinelands portion of the Township. It should be noted that the Pinelands Commission will need to adopt regulations to implement the requirements contained in N.J.S.A. 52:27D-329.9...

Ordinance No. 7

AN ORDINANCE TO AMEND ORDINANCE NO. 16 OF 2012

WHEREAS, the Township of Egg Harbor adopted Ordinance No. 16 of 2012 on April 25, 2012; and

WHEREAS, the purpose of Ordinance No. 16 of 2012 is to sell Block 1437, Lot 73 to Arc of Atlantic County for the construction of an affordable housing unit; and

WHEREAS, Section 3g of Ordinance No. 16 of 2012 required closing to take place prior to December 31, 2012; and

WHEREAS, due to circumstances beyond the control of both parties, closing was unable to occur prior to December 31, 2012; and

WHEREAS, the Township still desires to convey the property to Arc of Atlantic County; and

WHEREAS, Arc of Atlantic County still desires to construct an affordable housing unit;

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Egg Harbor, County of Atlantic, State of New Jersey that:

Section 1: Section 3g of Ordinance No. 16 of 2012 is hereby amended as follows:

g. Closing on property shall take place prior to December 31, 2013

SECTION 2: All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are, to the extent of such inconsistency, hereby repealed.

SECTION 3: Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

SECTION 4: This Ordinance shall take effect upon final passage, adoption and publication in the manner prescribed by law.

SECTION 1: Chapter 132, Article II, of the Code of the Township of Egg Harbor, entitled "Deer Driving", is hereby rescinded in its entirety.

SECTION 3: The Code of the Township of Egg Harbor is hereby amended by adding the following section §132-5 as follows:

§132-5. Violations and Penalties

Violation of any provision of this chapter shall, upon conviction thereof, be punished by a minimum fine of \$100 or a maximum of \$2,000 or by imprisonment for a term not exceeding 90 days or by a period of community service not exceeding 90 days. Each and every violation shall be considered a separate violation. Any person who is convicted of violating the provisions of this chapter within one year of the date of a previous violation and who was fined for the previous violation may be sentenced by the Court to an additional fine as a repeat offender. The additional fine imposed as a repeat offender shall not be less than the minimum or exceed the maximum fine provided herein, and same shall be calculated separately from the fine imposed for the violation of this chapter.

SECTION 4: All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.

SECTION 5. AN ORDINANCE TO AMEND CHAPTER 107 OF THE TOWNSHIP CODE ENTITLED "EXPLOSIVES"

BE IT ORDAINED by the Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey, as follows:

SECTION 1. Chapter 107 of the Code of the Township of Egg Harbor, Section 107-3 is hereby amended by deleting it in its entirety and replacing it as follows:

§107-3 Definitions

The meanings and definitions of words and phrases set forth in the statutes of New Jersey as they apply to the Bureau of Engineering and Safety, New Jersey Department of Labor and Industry, and the rules and regulations promulgated thereunder shall apply to words and phrases as used herein. The term "explosives" except as specifically stated in this chapter, shall not include small arms ammunition.

SECTION 2. Chapter 107 of the Code of the Township of Egg Harbor, Section 107-4A is hereby amended by deleting it in its entirety and replacing it as follows:

§107-4A Permits

- A. (1) It shall be unlawful to transport, manufacture, keep, use, store or handle, for any purpose whatsoever, any explosive, gunpowder, fireworks, dynamite, munitions and other dangerous and combustible articles and substances within the Township of Egg Harbor without having first obtained a permit to do so from the Township Committee of the Township of Egg Harbor.
- (2) No permit shall be required for the storage or use of smokeless powder which is used by private persons for the hand loading of small arms ammunition and which is not for resale. For this purpose not more than thirty-six (36) pounds of smokeless powder and not more than five (5) pounds of black powder shall be stored without a permit.

SECTION 3: All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by a Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF EGG HARBOR, CHAPTER 225 THEREOF ENTITLED "ZONING", SPECIFICALLY TO ADD A NEW SUBSECTION 225.49.1 ENTITLED "AFFORDABLE HOUSING REGIONAL GROWTH ZONE 12"

BE IT ORDAINED, by the Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey as follows:

SECTION 1: Chapter 225 of the Township Code is hereby amended to add a new section following Section 225-49 to be known as Section 225-49.1 as follows:

225.49.1 Affordable Housing Regional Growth Zone 12

- A. Intent. The Planning Board has adopted a housing element & fair share plan element of master plan that recommends that the area in question be utilized for one hundred percent (100%) affordable housing.
- B. Purpose. The purpose of the AH-RG-12 zoning district is to establish a zoning district to provide for a one hundred percent (100%) affordable housing development when said uses can be adequately serviced by the sanitary sewer system.
- C. Zoning created. There is created an AH-RG-12 a one hundred percent (100%) affordable housing zoning district. The following area shall comprise the AH-RG-12 zoning district: Block 1926, Lot 1 and Block 1927, Lots 1 & 3
- D. Permitted principal uses shall be:
 - (1) One hundred percent (100%) affordable multi-family attached housing development targeted for disabled veterans and veterans of the armed forces of the United States of America.
- E. Permitted accessory uses shall be:
 - (1) Public and private parking;
 - (2) Clubhouse, playground or other recreational amenities normally associated with the principal residential use;
 - (3) Rental and/or administrative offices accessory to the principal residential use; and
 - (4) Other uses and structures customarily incidental to a principal permitted use.
- F. Area, yard and building requirements shall be in accordance with Section 225-7 which is amended and supplemented as follows:

AH-RG-12 (100% Affordable Residential)

Minimum Lot Area:	5 Acres
Minimum Lot Width:	400 Feet.
Minimum Front Setback:	100 ft. (Township Road).
Minimum Rear Setback:	30 ft.
Minimum Side Setback:	30 ft.
Parking Setback:	30 ft.
Maximum height:	4 stories or 50 ft. whichever is less.
Minimum distance between buildings:	50 ft.
Maximum impervious coverage:	50%.

Maximum Density: 12 units/acre

- G. Conditional uses:
- (1) Public uses; and
 - (2) Essential services.
- H. Other requirements shall be:
- (1) All uses must be serviced by public water and public sanitary sewers;
 - (2) A buffer strip of twenty-five (25) feet in width shall be required along all property lines. The buffer shall be in accordance with the requirements contained in Chapter 94-8.
- I. Site plan review. All development shall be subject to Chapter 198 of the Code of the Township of Egg Harbor.
- J. Parking area requirements. Off-street parking shall be one and one half parking spaces per housing unit.
- K. Subdivision and Site Plan review. All development shall be subject to Chapter 198 of the Code of the Township of Egg Harbor.
- L. Buffer requirements. All development shall be subject to Chapter 94-8 of the Code of the Township of Egg Harbor as supplemented herein. In the event of a conflict between 94-8 and the contents within this ordinance, the provisions of the requirements within this ordinance shall control.
- M. Lighting requirements. All development shall be subject to Chapter 94-23 of the Code of the Township of Egg Harbor.
- N. Landscaping requirements. All development shall be subject to Chapter 94-22 of the Code of the Township of Egg Harbor.
- O. Signs. All development shall be subject to Article VIII of Chapter 225 of the Code of the Township of Egg Harbor.
- P. Recreation requirements. The following recreational improvements are required:
- (1) Indoor recreational space, a minimum of 600 hundred square feet is required;
 - (2) Walking trail, a minimum width of 5 feet with a minimum length of 600 feet is required;
 - (3) A covered gazebo with a minimum diameter of 24 feet is required;
 - (4) A playground designed for children under the age of twelve which is a minimum of 2,500 square feet in area is required; and
 - (5) A picnic area which covers an area of 2,500 square feet in area and contains at least picnic tables and one barbeque grill is required.
- Q. Essential and Non-severable condition of approval. An essential and non-severable condition of any approval to develop in the AH-RG-12 Zone shall be full compliance with an agreement between the Township of Egg Harbor and Renewable Jersey at Egg Harbor, LLC its successors and/or assigns.

SECTION 2: Section 225-5 entitled "Zoning Map" is hereby amended to create a new zoning designation of AH-RG-12 as shown on attached Exhibit A. The zone shall consist of Block 1926, Lot 1 and Block 1927 Lots 1 and 3.

SECTION 3: All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are, to the extent of such inconsistency, hereby repealed.

SECTION 4: Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

SECTION 5: This Ordinance shall take effect upon final passage, adoption, publication in the manner prescribed by law and following the Superior Court of New Jersey approval of an agreement between the Township of Egg Harbor, the Planning Board of the Township of Egg Harbor and Renewable Jersey at Egg Harbor, LLC and any appeals being resolved to the satisfaction of the parties hereto.
