Minutes**

Mayor McCullough called the meeting to Order at 5:00 p.m.

Township Clerk Tedesco read the Opening Statement Pursuant to the Open Public Meetings Act.

Also in attendance were Township Administrator Miller, Township Solicitor Friedman, Township Engineer Representative Watkins and Township Clerk Tedesco.

Township Clerk Tedesco read the Video Broadcast/Television Statement.

Mayor McCullough led the Pledge of Allegiance.

Meeting with Township Engineer

Engineer Representative Watkins advised the results of the asbestos inspection of the recently acquired West Atlantic City properties has been completed. All structures have some amount of asbestos present. The Township Engineer's Office will work with the Atlantic County Improvement Authority to develop a plan to remove the asbestos which must be done prior to any demolition work.

Mayor McCullough directed Township Engineer Watkins to contact the county about the poor condition of the bridge on Ridge Avenue.

New Business reported by Administrator Miller

Prescription Plan

Benecard increased their rates by 43 percent for renewal of the township prescription plan. This increase would result in an additional \$20,000 cost to the township per month. A better rate was secured from State Health Benefits with the same level of coverage. Resolution 136 authorizes renewal of the prescription benefit program with Benecard Services, Inc. through April 30, 2015 as the township needs to provide them with 60 day notice to cancel. Resolution 137 authorizes participation in the New Jersey State Health Benefits Program Act of the State of New Jersey for local prescription drug coverage.

Municipal Court 3rd Party Collection Contract

The township received a 30-day notice to quit after the current contract was only in effect for 1 year. The vendor advised the cost to maintain the required performance bond outweighed the amount of their compensation. The state confirmed the 30-day language in the original contract which allowed either party to

cancel without cause is not mandatory. This contract will be bid again in April and award is anticipated to be listed for consideration at the May 6, 2015, Township Committee meeting.

Open Space Referendum

Mayor McCullough stated he wants the governing body to have the ability to not collect the two cent Open Space Tax in a bad budget or bad tax year. An ordinance would be required in order for a question to be placed on the November ballot. Administrator Miller cautioned that once the rate is lowered, tax payers may perceive that when the rate increases back to two cents it would be an increase. Township Committee agreed to discuss this matter further.

2015 Budget

The Township Committee advised they need more time to review Administrator Miller’s municipal budget recommendations. The budget is tentatively scheduled to be introduced on March 18, 2015 and adopted on April 22, 2015.

Other Business (not listed on the Agenda)

Administrator Miller reviewed the Supplemental Agenda which includes Resolution 147 which provides for an emergency temporary budget for salt supplies due to the recent snow and ice accumulation. Also Resolution 146 granting FMLA leave to Kathy Fiedor and Resolution 149 appointing various individuals to the serve the Department of Parks and Recreation.

Presentations

Egg Harbor Township Board of Education

Mayor McCullough presented the key to the Bargaintown School, presently known as the Eagle Academy to School Board President James Galvin. Mayor McCullough explained the Township Committee felt that it was appropriate for the township to deed this property back to the Board of Education. School Board President Galvin thanked the Township Committee and advised they have recently installed new windows, HVAC system and electrical wiring totaling \$250,000. School Superintendent McCartney also expressed his thanks to the Township Committee for this generous donation.

Presentation by Egg Harbor Township Nature Reserve

Marc Friedman, Chairman of the Nature Reserve Committee recognized various members of the Nature Reserve Committee including Steve Nehmad, Nick Fasola, John Jones and volunteer Nathan Vary. The architect for this project is Jay Adamson. Mr. Freidman explained the committee has met extensively to develop a vision plan and outlined their plan for future improvements through a visual presentation. The committee is hopeful to establish various programs and they are very pleased with the amount of people who are enjoying the park.

Reports

Township Committee:

Committeeman Finnerty had nothing to report.

Committeeman Cafero recognized the Nature Reserve Committee for their efforts and noted the park has turned out to be a wonderful project. He also wished the Board of Education good luck on the Eagle Academy property donation.

Deputy Mayor Hodson said he was happy to see the public enjoying the Nature Reserve. Mr. Hodson cautioned the public to be aware of icy patches and pot holes on the roadways due to the recent snow and ice events. The Deputy Mayor encouraged the public to report pot holes to the Department of Public Works or via the township's website.

Committeewoman Pfrommer announced the annual Rabies Clinic will be held on March 14, 2015 at the Public Works garage located on Mill Road. Mrs. Pfrommer expressed her thanks to the Public Works employees for working 24/7 to clear the municipal roadways during the numerous winter snow events.

Mayor McCullough recognized the fire department for the recent ice rescue drill they coordinated at Lake Lenape. The Mayor expressed concern over the number of jobs lost as a result of the recent casino closures. The Mayor stated he contacted Congressman LoBiondo about a possible extension to unemployment benefits for those affected by the closures. Mayor McCullough said he also has written to President Obama comparing this area to that of Detroit, Pittsburgh and West Virginia and requesting his consideration to assist with an extension of unemployment benefits to this area. Lastly, the Mayor said it is his opinion that the Atlantic County Board of Taxation should utilize foreclosures, short sales and sheriff's sales as compatibles. The Mayor said Judy Campbell, representing the State Division of Taxation recently contacted him in reply to his letter asking if it would be permissible to utilize foreclosures, short sales and sheriff's sales as comparables. Ms. Campbell advised there is not any policy or statute that would forbid this request. The Mayor stated this will be a challenge for the County Board of Taxation and our local Assessor as tax rates increase when ratables decrease. However, he feels tax payers who wish to challenge their assessment should be able to utilize these options.

AN ORDINANCE PROVIDING FOR THE DONATION OF BLOCK 8503, LOT 29 TO SCULLVILLE VOLUNTEER FIRE COMPANY

WHEREAS, the Township of Egg Harbor received a request from the Scullville Volunteer Fire Company requesting the donation of a Township owned lot for their use; and

WHEREAS, the Township's owned lot is adjacent to a fire station owned and operated by the Scullville Volunteer Fire Company; and

WHEREAS, a municipality may donate property to a duly incorporated New Jersey non-profit corporation who services the public, and which property is not needed for municipal purposes to such a non-profit corporation for the benefit of its members, providing that if such property is not utilized for such purposes and within such time limits as the municipality may set, then the property shall revert to the municipality; and

WHEREAS, the Township Committee of the Township of Egg Harbor wishes to donate Block 8503, Lot 29, to a New Jersey nonprofit corporation, Scullville Volunteer Fire Company, and upon such conditions as are expressed herein.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey that:

SECTION 1: The Township of Egg Harbor is the record owner of the lands known as Block 8503, Lot 29, 1401 Mays Landing Somers Point Road; and

SECTION 2: The Township of Egg Harbor hereby authorizes the donation all of its right, title, and interest in the premises described above to the Scullville Volunteer Fire Company, and hereby authorizes the Mayor and Township Clerk to execute said documents as are necessary for the lawful conveyance under the terms and provisions provided herein.

SECTION 3: The aforementioned premises has been determined by the Township Committee that it is not needed for public purposes and may be conveyed under the following terms and conditions:

- a. The Township of Egg Harbor makes no representations or warranties as to the quality of title or the permissible use of any aspect of the property being conveyed. The Scullville Volunteer Fire Company shall conduct its own inspection of the property and the quality of title.

- b. The property conveyed shall be used only for the purposes for which the Scullville Volunteer Fire Company has been incorporated and shall not be used for any commercial business enterprise.
- c. In the event of a breach by the purchaser of any of the provisions contained within the ordinance, the Township shall have an automatic right of reverter and upon notification of the Scullville Volunteer Fire Company, the lands shall revert back to the Township. This right of reverter shall be in the Deed of Conveyance.

SECTION 4: All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are, to the extent of such inconsistency, hereby repealed.

SECTION 5: Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

SECTION 6: This Ordinance shall take effect upon final passage, adoption and publication in the manner prescribed by law.

AN ORDINANCE TO AMEND CHAPTER 118 OF THE TOWNSHIP CODE ENTITLED "GARBAGE, RUBBISH, REFUSE, AND RECYCLING"

BE IT ORDAINED, by the Township Committee for the Township of Egg Harbor, County of Atlantic and State of New Jersey that:

SECTION 1: Chapter 118 of the Township Code, specifically Section 118-7 is hereby amended by deleting it in its entirety and replacing it with the following:

§118-7 Program established.

There is hereby established a program for mandatory recycling from the solid waste flow within the Township of Egg Harbor for the following items:

AN ORDINANCE DONATING LANDS TO THE EGG HARBOR TOWNSHIP BOARD OF EDUCATION

WHEREAS, the Egg Harbor Township Committee accepted a donation of Block 69E, Lot 14 (NKA Block 5610, Lot 14) from Egg Harbor Township Board of Education by adoption on June 23, 1993 of Ordinance No. 29 of 1993; and

WHEREAS, the property is commonly known as Bargaintown School; and

WHEREAS, the Township has leased this property to the Egg Harbor Township Board of Education continuously since October 28, 1999; and

WHEREAS, in anticipation the Board of Education making substantial capital investment in the Bargaintown School, the Township and Board of Education entered into a lease on August 1, 2013 for fifteen (15) academic years (2013-14 through 2027-28); and

WHEREAS, the Egg Harbor Township Board of Education operates an alternate school program for its at risk youth at the Bargaintown School, 3517 Bargaintown Road; and

WHEREAS, the Board of Education has made a long-term financial commitment to the school; and

WHEREAS, the Board of Education has requested the Township to transfer title of the property to them; and

WHEREAS, the Township Committee of the Township of Egg Harbor wishes to donate Block 5610, Lot 14 to the Egg Harbor Township Board of Education upon such conditions as are expressed herein.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey that:

SECTION 1: The Township of Egg Harbor is the record owner of the lands known as Block 5610, Lot 14, known as 3517 Bargaintown Road; and

SECTION 2: The Township of Egg Harbor hereby authorizes the donation all of its right, title, and interest in the premises described above to the Egg Harbor Township Board of Education, and hereby authorizes the Mayor and Township Clerk to execute said documents as are necessary for the lawful conveyance under the terms and provisions provided herein.

SECTION 3: The aforementioned premises have been determined by the Township Committee that it is not needed for municipal purposes and may be conveyed under the following terms and conditions:

- d. In the event of a breach by the Egg Harbor Township Board of Education of any of the provisions contained within this ordinance, the Township shall have an automatic right of reverter and upon notification of the Egg Harbor Township Board of Education; the lands shall revert back to the Township. This right of reverter shall be in the Deed of Conveyance.
