Call to Order

Mayor McCullough called the meeting to order at 5:00 p.m.

Meeting with Township Engineer Mott

- In Engineer Mott’s absence, Administrator Miller reported on the vacation of Lakewood Avenue between Reega Avenue and Eisenhower Avenue.

Old Business

Purchase of Block 1927, Lot 3. Administrator Miller spoke about the Township purchasing this property for the sum of \$1,053 for the purpose of facilitating COAH Affordable Housing. Once the owner of the property received a revaluation of the property, the value increased to \$1,300; and as a result, the owner asked that the purchase price be adjusted to \$1,300. Ordinance 11 is on the agenda this evening to amend the purchase price as requested.

New Business

- Building height ordinance amendment. Administrator Miller advised the Committee that in accordance with the FEMA advisory flood elevation maps which affects areas in the Township, Ordinance 16 is on the agenda this evening to increase the vertical distance from grade to the top of the highest roof beams of a flat roof or the mean level of the highest gable or slope of a hip roof for properties located in any FEMA designated flood zone.
- Mercantile licensing fee schedule (Chapter 142). Administrator Miller and the Township Committee discussed the increase of the mercantile license fees which have not been increased in over 20 years. The Committee expressed that the Economic Development Commission had concerns regarding the doubling of the fees and Administrator Miller indicated he met with them and they expressed no concerns. Administrator Miller indicated that the fees were looked at in comparison to the fees charged by surrounding municipalities and they are not out of line. Administrator Miller will discuss the fees with the Economic Development Commission once more before the scheduled adoption of the ordinance.
- 2013 Municipal Budget. Mayor McCullough advised Administrator Miller that the Committee has begun their review process and will be meeting with him shortly.

Other Business (not listed on the Agenda)

Administrator Miller advised that there are several items to be discussed that were not on the agenda.

- Additional resolutions (confirming land sale; authorizing coin drop; FMLA leave for employee J Constantine and the execution of Municipal Alliance Agreement).
- Additional items to be added to the bill list: two bills for Arawak Paving for final payments for projects known as reconstruction of Reega Avenue and Road Improvement Program.

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF EGG HARBOR, CHAPTER 94 THEREOF, ENTITLED "DESIGN, PERFORMANCE AND IMPROVEMENT STANDARDS"

BE IT ORDAINED, by the Township Committee for the Township of Egg Harbor, County of Atlantic and State of New Jersey that:

SECTION 1: Chapter 94 of the Township Code, specifically Section 94-44D(5)(a) is hereby amended by deleting the existing paragraph and replacing it as follows:

- (a) For all major developments, the design engineer, using the assumptions and factors for stormwater runoff and groundwater recharge calculations contained in §94-44C shall either:
1. Demonstrate through hydrologic and hydraulic analysis that the postdeveloped project site maintains 100% of the site's predeveloped average annual groundwater recharge volume; or
 2. Demonstrate through hydrologic and hydraulic analysis that any increase in the project site's stormwater runoff volume for the two-year, twenty-four-hour storm from predeveloped to postdeveloped conditions is infiltrated on site

SECTION 2: Chapter 94 of the Township Code, specifically Section 94-44D(5)(d) is hereby amended by deleting section d in its entirety.

AN ORDINANCE TO AMEND CHAPTER 142 OF THE TOWNSHIP CODE ENTITLED "MERCANTILE LICENSING",
SPECIFICALLY SECTION 142-16

BE IT ORDAINED, by the Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey as follows:

SECTION 1. The Code of the Township of Egg Harbor is hereby amended by deleting Section 142-16A in its entirety and replacing with the following:

§142-16. License fee schedule.

- A. The license fees per year established in this section shall be in accordance with the following schedule, except those set forth in other sections of the Township Code:
- (1) Amusement park (other than as defined in Chapter 65), arcade, bowling alley, driving range, ice/roller skating and similar recreational facilities: \$400.
 - (2) Asphalt or concrete products, fabrication of construction materials, recycling: \$400.
 - (3) Auctioneer: \$100, plus a bond pursuant to §67-2F.
 - (4) Automobile service station, repair garage, towing and storage of motor vehicles (other than a junk or salvage yard): \$150.
 - (5) Full-service automobile and recreational vehicle agency, for related services, repairs and retail sales of parts, not including watercraft: \$600.
 - (6) Motor Vehicle Rental: \$200
 - (7) Coin-operated vending devices, including amusement, video, food, beverage and novelties: \$20 per device.
 - (8) Hotel/motel or any similar facilities which furnish sleeping accommodations for short-term guests: \$200, plus \$20 per sleeping room.
 - (9) Circus, carnival or flea market conducted for other than nonprofit fund-raising: \$400.
 - (10) Retail and wholesale sales, warehouse and storage of goods:
 - (a) Two thousand square feet or less: \$100.
 - (b) For each additional 1,000 square feet or fraction thereof: an additional \$20 per 1,000 square feet.
 - (11) Junk or salvage yard: \$400.
 - (12) Motion-picture theater: \$400, plus \$200 for each screen.

(13) Restaurants; snack bars and concession stands.

- (a) Restaurant with a seating capacity of up to 30 seats: \$200, plus \$1 per seat in excess of 30 seats.
- (b) Snack bar and concession stands (not included as part of a restaurant): \$100.
- (c) Bar stools are not included as seats for purposes of calculating the fee.

(14) Marina operations.

- (a) Dry dock/storage: \$150.
- (b) Repairs, supplies (including fuel) and watercraft rental: \$200.
- (c) Rental slips/docks: \$2 per slip/dock.

(15) Automated car wash, laundry and laundromat, dry cleaning: \$200.

(16) Training schools for profit, including but not limited to dance, gymnastics, martial arts, music and trades: \$150.

(17) Repair, supply or service business not otherwise classified: \$150.

(18) Seasonal business customarily associated with a holiday, not to exceed 60 days: \$25.

(19) Precious metals (Chapter 172), retail and wholesale sales: \$500
