MINUTES

Mayor McCullough called the Meeting to Order, 5:01 PM.

Township Clerk Tedesco read the Opening Statement Pursuant to the Open Public Meetings Act.

Also in attendance was Township Administrator Miller, Solicitor Friedman and Township Clerk Tedesco.

New Business

Capital Budget Appropriations

Administrator Miller referred to Resolution No. 187, Resolution re-appropriating funds from one category to another within the same ordinance (various) and Resolution No. 188 canceling outstanding balance from capital and bond amounts to capital surplus account (various). Mr. Miller explained that funds will be applied from various accounts towards the purchase of new equipment for Public Works and firearms for the Police Department. Township Committee had no objections.

MUA Refinancing

Township Administrator Miller referred to Resolution No. 183, authorizing the Mayor to execute an insurance agreement on behalf of the Egg Harbor Township Municipal Utilities Authority listed on the Consent Calendar. Mr. Miller explained that since the township created the Municipal Utilities Authority, we are required to execute an insurance agreement on their behalf as part of their refinancing conditions. The township would be ultimately responsible for their debt should they default.

Township Refinancing

Administrator Miller advised that after conferring with the township's financial advisor the township will be able to lower its debt, saving approximately \$70,000 by refinancing. Mr. Miller anticipates re-financing will occur this summer.

Prescription Renewal

Administrator Miller said the township is in the process of renewing its contract for prescription services. The township received a \$17,000 rebate because our utilization claims are down. He anticipates the township will receive approximately \$20,000 next year if the trend continues. There was a brief discussion regarding the all-around savings for using mail order prescriptions.

Ambulance Fees

Township Administrator Miller reported that he has recently discussed increasing ambulance fees with Ambulance Director Higbee. Mr. Higbee performed a survey of fees charged by surrounding municipalities as well as, AtlantiCare and has recommended our BLS fees be increased to \$650 and \$700 for residents and non-residents respectively, mileage rate will be increased to fifteen cents per mile and \$100 for refusal of service. Following a brief discussion, Township Clerk Tedesco was asked to obtain rates from several neighboring municipalities to use in comparison to the proposed fees.

Other Business

Mayor McCullough recognized Bargaintown Volunteer Fire Department Assistant Chief, Will Hancock in the audience. The Mayor reported that the South Jersey Transportation Authority announced at their meeting earlier today that they will be increasing fees paid to fire companies called to respond to the Atlantic City Expressway from \$75 to \$150. This increase is expected to go into effect shortly.

Mayor McCullough asked Solicitor Friedman for his opinion on the fire department's request to transfer a fire truck. Solicitor Friedman advised state law requires acquisitions in excess of \$200,000 remain in the name of the municipality and any proceeds from the sale of that item be disbursed by the municipality. He does not believe the township has the ability to donate a vehicle to a non-profit organization and that they in turn would have the ability to sell and retain the proceeds. Following a brief discussion the governing body will look into the possibility of selling a fire truck to the fire department for a nominal amount.

AN ORDINANCE PROVIDING FOR THE ACCEPTANCE OF A DEED CONVEYING REAL PROPERTY, DRAINAGE BASIN AT ZION WOODS, BEING LOT 31.17 IN BLOCK 5926 OF THE OFFICIAL TAX MAP IN THE TOWNSHIP OF EGG HARBOR, COUNTY OF ATLANTIC AND STATE OF NEW JERSEY

BE IT ORDAINED, by the Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey that:

SECTION 1: The Township of Egg Harbor is herewith authorized to accept conveyance of a deed for the drainage basin at Zion Woods, located on Lot 31.17 in Block 5926, of the Official Tax Map of the Township of Egg Harbor, and as more particularly described on the attached Exhibit A, Deed between Group Land Development, Ltd and the Township of Egg Harbor. Exhibit A shall be on file in the Township Clerk's Office, Township Hall, Township of Egg Harbor, County of Atlantic and State of New Jersey.

SECTION 2: The Township Clerk shall immediately, upon final passage and publication of this Ordinance, make and file in the Office of the Clerk of the County of Atlantic a copy of this Ordinance, together with a copy of the proof of publication thereof, duly certified by her, under the corporate seal of the Township of Egg Harbor, for recording as required by law.

SECTION 3: All ordinances and parts of Ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

SECTION 4: Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.

SECTION 5: This Ordinance shall become effective immediately upon final adoption and publication according to law.
