### **Limousine Hearings**

Owner/Driver – Bikhit (5:00 p.m.)

Prosecutor Marc Nehmad reviewed township code regarding licensing of limousine owners and drivers.

Sergeant Michael Hughes was sworn in by Solicitor Friedman and he reviewed Mr. Bikhit's violations and outcomes. Sergeant Hughes explained the Police Department denied Mr. Bikhit's application based on the totality of charges.

Mr. Bikhit was sworn in by Township Solicitor Friedman. Mayor McCullough asked Mr. Bikhit to explain why the Governing Body should approve his license in light of the Police Department's findings and recommendation to deny.

A lengthy discussion ensued regarding the various charges. Mr. Bikhit felt he made mistakes, but should be issued a license in order to support his family. Mr. Bikhit stated he is currently licensed for limousine service in the City of Atlantic City. Mayor McCullough explained Township Committee will make a decision based upon the information provided at this hearing and he will be advised by the Township Clerk of their decision by Monday, July 6, 2013.

### **New Business**

Bargaintown School Lease

Administrator Miller explained Ordinance 25 listed for introduction authorizes an inter-local services agreement between the township and the Egg Harbor Township Board of Education. The agreement will allow the Board of Education use of the facility through the year 2018. The Board of Education will be responsible for maintenance of this building/property during the term of agreement.

Township Committee had no objection and will act upon Ordinance 25 later in the evening.

Mercantile Licensing Amendments

Township Clerk Tedesco explained proposed expansion of categories would provide clarity as the current list is rather broad and vague in its description. Additionally revisions of several sections of the code regarding housekeeping procedures are being recommended to provide for a more streamlined process.

Township Committee had no objections and an ordinance will be introduced at a future meeting.

2012 Municipal Audit

Administrator Miller stated the 2012 Audit has been issued and Resolution 242 certifying to the Local Finance Board that the Governing Body has reviewed the annual audit recommendation is listed for consideration on the Consent Calendar.

Sustainable Jersey Municipal Certification Program

Administrator Miller explained Resolution 246 authorizes the Township’s participation in the Sustainable Jersey Municipal Certification Program. Under the program, township officials would explore and adopt sustainable, economically-sound, local government practices. Resolution 246 designates Administrator Miller to serve as the Township’s agent for Sustainable Jersey Municipal Certification process.

Administrator Miller advised the nature park is eligible, but certification is needed. With adoption of Resolution 246, Donna Burger, Clean Communities Coordinator can work towards attaining a grant and pursue municipal certification.

Township Committee will act upon a resolution later in the meeting.

Donation of Block 8006, Lot 32

Administrator Miller stated Ordinance 26 provides for the acceptance of a deed from the Estate of John W. Perry for land located on Valerie Road. The land is being offered as a donation and is located near the Atlantic County Golf course on Somers Point Mays Landing Road.

Township Committee did not express any objection to Ordinance 26.

**Other Business (not listed on the Agenda)**

Administrator Miller advised the agenda was revised to include Resolutions 270 through 274 of 2013. Resolution 266 was changed to include both Felonee Rhoads and Samantha Rodriguez. Lastly, Administrator Miller asked Township Committee to consider payment of additional bills to cover translation services in the amount of \$161.25 and \$191.37. Mr. Miller also advised the Tax Collector’s office is currently receiving applications for a clerical position and requested permission to appoint the successful candidate retroactive at the July Township Committee meeting.

**General Public Discussion**

Genaro Basil, Ridge Avenue requested Township Committee's consideration to revise the current 10 foot setback for accessory structures to 5 foot. Mr. Basil said current standard is unrealistic given the size of most sub-division lots. Also, the variance process is very costly to the average resident. Mayor McCullough advised his request will be turned over the Township Administrator for consideration.

Eman Daoud, 112 Woodside Drive inquired about the status of her limousine driver application as well as, that of her driver, Ken Renard per a March 2013 letter from the Township Clerk's office. Clerk Tedesco advised Ms. Daoud's application is pending her submission of DMV documentation as previously instructed. The letter from March 2013 to Mr. Renard explains the State Police had not yet processed his criminal history request and that further; Mr. Renard would need to supply the Clerk's office with the name of a licensed limousine owner in order to release his license.

**Engineer's Report**

Superstorm Sandy Projects (Seaview Harbor and Anchorage Poynte)

Administrator Miller advised Resolution 247 awarding contract for miscellaneous storm damage projects to Ocean Construction, LLC is listed on the consent calendar for consideration tonight. The contract includes repairs to damaged roadways in Anchorage Poynte.

Township Administrator Miller said new preliminary FEMA maps have been distributed and include West Atlantic City, Seaview Harbor, Anchorage Poynte, and Morris Beach. These areas went from a V zone to an A zone. There appears to be a discrepancy over the zones which the Township Engineer is investigating. A brief discussion ensued.

Resolution 241 authorizes an item of revenue in the amount of \$28,000 to be included in the budget as a Chapter 159 and applied towards repairs to the Police Department as a result of recent storm flooding and associated damage to the building.

**ORDINANCE APPROPRIATING \$2,430,000 AND AUTHORIZING THE ISSUANCE OF \$2,200,000 BONDS OR NOTES OF THE TOWNSHIP FOR VARIOUS IMPROVEMENTS OR PURPOSES AUTHORIZED TO BE UNDERTAKEN BY THE TOWNSHIP OF EGG HARBOR**

---

**BE IT ORDAINED**, by the Township Committee of the Township of Egg Harbor, in the County of Atlantic, New Jersey (not less than two thirds of all the members thereof affirmatively concurring), as follows:

**SECTION 1:** The Township of Egg Harbor, in the County of Atlantic, State of New Jersey (hereinafter referred to as "Township") hereby authorizes the improvements and acquisitions described in Section 3(A) of this Bond Ordinance (hereinafter referred to as "Purposes") to be undertaken by the Township as general improvements the costs of which shall be borne by the Township at large. For the Purposes described in Section 3(A) the Township hereby appropriates the sum of \$2,430,000 including the sum of \$230,000 as the down payments required by the Local Bond Law. It is hereby determined and stated that the amount of the down payment is not less than five percent (5%) of the obligations authorized by this Bond Ordinance and that the amount appropriated as a down payment has been made available prior to final adoption of this Bond Ordinance by provisions in prior or current budgets of the Township for capital improvements and down payments, including also monies received from the United States of America, the State of New Jersey or the County of Atlantic, or agencies thereof, as grants in aid of financing said improvements or purposes.

**SECTION 2:** In order to finance the cost of the Purposes not covered by application of the down payments, negotiable bonds are hereby authorized to be issued by the Township in the principal amount of \$2,200,000 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued by the Township pursuant to and within the limitations prescribed by the Local Bond Law.

**SECTION 3:** A. The purposes hereby authorized and for which the bonds are to be issued, the estimated cost of each Purpose and the appropriation therefore, the estimated maximum amount of bonds or notes to be issued for each Purpose and the period of usefulness of each Purpose are as follows:

B. The excess of the appropriation made for each of the aforesaid Purposes over the estimated maximum amount of bonds or notes to be issued therefore, as above stated, namely an aggregate amount of \$230,000 is the amount of the down payments for said Purposes.

C. The estimated cost of each Purpose is equal to the amount of the appropriation herein made therefore.

**SECTION 4:** All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer, provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with notes issued pursuant to this bond ordinance, and the Chief Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. 40A:2-8(a). The Chief Financial Officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers therefore upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

**SECTION 5:** The Township hereby certifies that it has adopted a capital budget. The applicable capital budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Township Clerk and available for public inspection.

**SECTION 6:** The following additional matters are hereby determined, declared, recited and stated:

A. The Purposes described in Section 3(A) of this bond ordinance are not current expenses. They are improvements and an acquisition that the Township may lawfully undertake as capital projects and general improvements, and no part of the cost hereof has been or shall be specially assessed on property specially benefitted thereby.

B. The period of usefulness of the Purposes within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this bond ordinance, is 12.373 years.

C. The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Township Clerk, and an executed copy has been electronically signed and filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the Township as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided for in this bond ordinance by \$2,200,000. The obligations authorized herein will be within all debt limitations prescribed by the Local Bond Law.

D. Amounts not exceeding FIFTEEN THOUSAND DOLLARS (\$15,000) in the aggregate for interest on said obligations, costs of issuing said obligations, architectural, engineering and inspection costs, legal expenses, a reasonable proportion of the compensation and expenses of employees of the Township in connection with the acquisition of such improvements and property as authorized herein, and other items of expense listed in and permitted under Section 40A:2-20 of the Local Bond Law have been included as part of the costs of said improvements and are included in the foregoing estimates thereof.

**SECTION 7:** Any funds received from the County of Atlantic, the State of New Jersey or the United States of America, or any of their agencies, shall be applied either to the direct payment of the cost of such Purposes, or to the payment of the bonds or bond anticipation notes issued pursuant to this bond hereunder and shall be reduced to the extent that such funds are so applied.

**SECTION 8:** The Township intends to finance the cost of the Purposes with an issue of tax-exempt bonds or bond anticipation notes in an amount not to exceed \$2,200,000. Costs of the Purposes that are properly payable prior to the issuance of the bonds or notes are reasonably expected to be paid initially from revenue. Revenues are available for this purpose only on a temporary and short-term basis pursuant to the budget of the Township, and there are no other funds available for this purpose on a long-term basis. The Township intends to reimburse itself for such costs from the proceeds of its bonds or notes. No cost of the Purposes to be reimbursed with the proceeds of bonds or notes is a cost of working capital. This public notice is a declaration of official intent pursuant to Treasury Regulations §1.103-18 of the United States Treasury.

**SECTION 9:** The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the bonds or bond anticipation notes authorized by this bond ordinance, and the amounts required for such payments shall in each year, while any of said bonds or notes are outstanding, be included in the annual budget. The bonds or notes shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy ad valorem taxes upon all the taxable real property within the Township for the payment of the obligations and the interest thereof without limitation as to rate or amount.

**SECTION 10.** This bond ordinance shall take effect twenty (20) days after the first publication hereof after final adoption, as provided by the Local Bond Law.

**REFUNDING BOND ORDINANCE AUTHORIZING THE ISSUANCE OF UP TO \$13,000,000 AGGREGATE PRINCIPAL AMOUNT OF GENERAL OBLIGATION REFUNDING BONDS OF THE TOWNSHIP OF EGG HARBOR TOWNSHIP, COUNTY OF ATLANTIC, NEW JERSEY**

---

BE IT ORDAINED BY THE COMMITTEE OF THE TOWNSHIP OF EGG HARBOR, COUNTY OF ATLANTIC, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), pursuant to the provisions of the Local Bond Law, Chapter 2 of Title 40A of the New Jersey Statutes, as amended and supplemented ("**Local Bond Law**"), as follows:

**Section 1.** For the purposes stated in Section 2 of this refunding bond ordinance ("**Ordinance**"), negotiable general obligation refunding bonds of the Township of Egg Harbor, County of Atlantic, New Jersey ("**Township**"), to be designated substantially "Township of Egg Harbor, General Obligation Refunding Bonds, Series 2013" ("**Refunding Bonds**"), are hereby authorized to be issued in an aggregate principal amount not to exceed \$13,000,000, pursuant to Sections 40A:2-51 to 40A:2-53 and Sections 40A:2-55 to 40A:2-59 of the Local Bond Law.

**Section 2.** The purposes for which the Refunding Bonds are authorized to be issued as permitted by Section 40A:2-51 of the Local Bond Law are:

(a) Paying or refunding of \$11,611,000 in aggregate principal amount of the Township's General Improvements Bonds, Series 2006, constituting the bonds of such series maturing on and after February 1, 2017 (the "**Prior Bonds**"); and

(b) Paying the costs of the issuance of the Refunding Bonds, including underwriting discount, insurance premium, printing, advertising, accounting, financial and legal expenses, in an amount not to exceed \$150,000, which amount is included in the authorized principal amount of the Refunding Bonds.

**Section 3.** Pursuant to Section 40A:2-58 of the Local Bond Law, the Refunding Bonds shall be issued in fully registered form, in the denomination of \$5,000 or any integral multiple thereof and shall mature at such time or times not exceeding thirteen (13) years from the date thereof. The Refunding Bonds shall bear a designation including the word "refunding", as provided in Section 1 hereof, and the text of the Refunding Bonds shall recite that such Bonds are issued pursuant to the Local Bond Law. All other terms of the Refunding Bonds, including, without limitation, the dates thereof, the rate or rates of interest to be paid thereon, the provisions for redemption prior to maturity thereof, and the place or places for payment thereof, shall be as determined by subsequent resolution or resolutions of the Committee of the Township of Egg Harbor (the "**Committee**"), as permitted by Section 40A:2-58 of the Local Bond Law.

**Section 4.** (a) In accordance with Section 40A:2-55 of the Local Bond Law, a certified copy of this Ordinance shall be filed before final passage thereof with the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey, together with a complete statement in the form prescribed by the Director ("**Director**") as required by Section 40A:2-55 of the Local Bond Law as to the Prior Bonds, executed by the Chief Financial Officer of the Township.

(b) The Prior Bonds have been issued by the Township pursuant to the Local

Bond Law and it is hereby confirmed and acknowledged that the Prior Bonds are valid and binding obligations of the Township.

**Section 5.** The full faith, credit and taxing power of the Township are hereby pledged to the payment of principal of and interest on the Refunding Bonds. The Local Bond Law provides that the Refunding Bonds shall be direct, unlimited obligations of the Township and that the Township shall be obligated to levy *ad valorem* taxes upon all the taxable property within the Township for payment of principal of and interest on the Refunding Bonds without limitation of rate or amount.

**Section 6.** Escrow funds pledged for the payment and security of the Prior Bonds are hereby authorized to be established with proceeds of the Refunding Bonds pursuant to an escrow agreement or agreements with respect to the Prior Bonds executed and delivered by the Township and any bank, trust company or national banking association with trust powers having its principal office in the State of New Jersey and designated by resolution of the Committee to act as escrow agent under such agreement. Such escrow agreement(s) shall be in form approved by subsequent resolution of the Committee.

**Section 7.** The Refunding Bonds shall be executed in the name of the Township by the manual or facsimile signatures of the Mayor and the Chief Financial Officer of the Township under the affixed, imprinted or reproduced seal of the Township attested by the manual or facsimile signature of the Township Clerk.

**Section 8.** The Committee is hereby authorized and directed to enter into any and all contracts or agreements necessary, desirable or convenient to effectuate the refunding program authorized by this Ordinance, including, without limitation, the payment and refunding of the Prior Bonds and in connection therewith the Committee may establish any sinking fund or other fund or account necessary or appropriate for such refunding program.

**Section 9.** In accordance with the provisions of N.J.A.C. 5:30-2.5, the Committee hereby determines that the following conditions apply to the issuance of the proposed Refunding Bonds:

- (a) the present value savings will be at least three (3%) percent;
- (b) No annual debt service payment on the Refunding Bonds shall be more than the debt service schedule on the Prior Bonds;
- (c) the final maturity of the Refunding Bonds shall not exceed the maturity date of the Prior Bonds; and
- (d) the debt service savings are substantially level across the life of the refunding transaction.

**Section 10.** The Mayor and members of the Committee and appropriate officials of the Township are hereby jointly and severally authorized and directed to take all actions and execute all documents and instruments necessary or appropriate to carry out the purposes of this Ordinance, including, without limitation, the furnishing of such documentation and information as may be required by the Director of the Local Finance Board pursuant to Section 40A:2-56 of the Local Bond Law. All prior actions taken by such officials in connection with the refunding program authorized by this Ordinance are hereby ratified and confirmed.

**Section 11.** This Ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.
