**WHEREAS**, across the nation, traffic crashes caused more than 35,092 fatalities in 2015 and are the leading cause of death for young people ages 15 to 34; and

**WHEREAS**, in New Jersey, 562 individuals lost their lives in traffic crashes in 2015; and

**WHEREAS**, alcohol-related crashes accounted for 28.0 percent of the State's traffic fatalities, while 26 percent of all fatal crashes involved traveling at unsafe speeds; and

**WHEREAS**, motorcyclists, bicycle riders and pedestrians face increased risks on New Jersey's roadways, as people opt for alternative modes of transportation; and

**WHEREAS**, 50 motorcyclists, 17 bicyclists and 173 pedestrians were killed in New Jersey in traffic-related crashes in 2015; and

**WHEREAS**, safer driving behaviors such as buckling up, every ride; obeying posted speed limits; stopping for pedestrians in crosswalks and using crosswalks when walking; avoiding aggressive driving behaviors ; never driving impaired; wearing proper safety gear while riding a motorcycle or bicycle; and, focusing solely on driving by avoiding distractions, can dramatically reduce the number of traffic-related injuries and deaths.

**NOW, THEREFORE BE IT PROCLAIMED**, that the Mayor and Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey do hereby proclaim October 10, 2016 as **PUT THE BRAKES ON FATALITIES DAY**® in the Township of Egg Harbor, and urge all citizens in our community and throughout the State to put these lifesaving behaviors into practice to improve safety on the roadways in our community and throughout the State.

AN ORDINANCE TO VACATE PORTION OF CAPE AVENUE, BETWEEN PENNSYLVANIA AVENUE AND TERMINUS, LOCATED IN THE TOWNSHIP OF EGG HARBOR, COUNTY OF ATLANTIC AND STATE OF NEW JERSEY AS SHOWN ON SHEET 52 OF THE TOWNSHIP TAX MAP

BE IT ORDAINED, by the Township Committee for the Township of Egg Harbor, County of Atlantic and State of New Jersey that:

SECTION 1: Portions of the following street, and all rights-of-ways thereto except those specifically excluded as set forth herein below, be and the same are hereby vacated and all public rights therein are extinguished, as shown on Sheet 52 of the Township of Egg Harbor's Tax Map.

Name of Street	From	To
Cape Avenue	Pennsylvania Avenue	Terminus

SECTION 2: The public rights arising from any dedication of the portion of the said streets above mentioned and indicated on maps filed in the Office of the Township Clerk and described above, so vacated as aforesaid, be and the same are hereby released and extinguished.

SECTION 3: By virtue of N.J.S.A. 40:67-1, as amended, vacation of any street, highway, lane, alley, square, place or park, et cetera, as defined in N.J.S.A. 40:67-1, shall be subject to the express reservation and exception from the vacation of all rights and privileges possessed by public utilities, as defined in N.J.S.A. 40:2-13 and by any cable television company as defined in the "Cable Television Act," P.L. 1972, c. 186, (C. 48:5A-1, et seq), to maintain, repair and replace their existing facilities in, adjacent to, over or under the street, highway, lane, alley, square, place or park, or any part thereof, to be vacated pursuant to this Ordinance.

SECTION 4: The Township Clerk shall immediately, upon final passage and publication of this Ordinance, make and file in the Office of the Clerk of the County of Atlantic a copy of this Ordinance, together with a copy of the proof of publication thereof, duly certified by her, under the corporate seal of the Township of Egg Harbor, for recording as required by law.

SECTION 5: All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are, to the extent of such inconsistency, hereby repealed.

**RESOLUTION PROVING FOR THE COMBINATION OF CERTAIN ISSUES OF NOT EXCEEDING \$5,225,000 GENERAL OBLIGATION BONDS, SERIES 2016 OF THE TOWNSHIP OF EGG HARBOR, IN THE COUNTY OF ATLANTIC, STATE OF NEW JERSEY, DELEGATING AUTHORITY TO DETERMINE THE FORM AND OTHER DETAILS OF SUCH BONDS, AND PROVIDING FOR THE SALE OF SUCH BONDS TO THE ATLANTIC COUNTY IMPROVEMENT AUTHORITY PURSUANT TO THE AUTHORITY'S 2016 POOLED GOVERNMENTAL LOAN PROGRAM**

**WHEREAS**, the Township of Egg Harbor (the "**Township**"), in the County of Atlantic (the "**County**"), State of New Jersey, has determined that there exists a need within the Township to finance the costs of various capital improvements throughout the Township, consisting of various roadway improvements, equipment and vehicle purchases for the Township's Public Works, Police and Fire Departments, purchases of computers and communication equipment and various other general capital improvements (collectively, the "**Capital Improvement Projects**"); and

**WHEREAS**, the Township Committee has duly adopted various bond ordinances (the "**Ordinances**") to appropriate moneys and authorize the issuance of bonds or bond anticipation notes to undertake the Capital Improvement Projects; and

**WHEREAS**, the Township has determined to finance the Capital Improvement Projects with the proceeds of a loan (the "**Loan**") to be made to the Township by the Atlantic County Improvement Authority (the "**ACIA**") in connection with the 2016 Pooled Governmental Loan Program, currently scheduled to close on or about October 21, 2016 (the "**2016 ACIA Pooled Loan Program**"); and

**WHEREAS**, in order for the Township to receive the Loan from the ACIA, it is necessary to combine the bonds authorized under said Ordinances into one consolidated issue of general obligation bonds in the aggregate principal amount of \$5,225,000 (to be issued in one series or more separate series aggregating said amount and to memorialize the applicable obligations of the general or utility funds of the Township, as and if applicable), pursuant to the provisions of the Local Bond Law, N.J.S.A. 40A:2-1 et seq., as amended and supplemented (the "**Local Bond Law**"); and

**WHEREAS**, to evidence the Loan, the ACIA also requires the Township to authorize, execute, attest and deliver the Township's \$5,225,000 General Obligation Bonds, Series 2016 (to be issued in one or more separate series aggregating said amount and to memorialize the applicable obligations of the general or utility funds of the Township, as and if applicable) (the "**Bonds**") in accordance with the provisions hereof and pursuant to the terms of the Local Bond Law, N.J.S.A. 40A:2-1 et seq. (the "**Local Bond Law**") and other applicable law; and

**WHEREAS**, Section 27(a)(2) of the Local Bond Law allows for the sale of the Bonds to the ACIA without any public offering, all under the terms and conditions set forth herein and in a Bond Purchase Agreement by and between the Township and the ACIA to be dated as of the date of the sale of such Bonds.

**NOW THEREFORE, BE IT RESOLVED BY A TWO-THIRDS VOTE OF THE FULL MEMBERSHIP OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF EGG HARBOR, IN THE COUNTY OF ATLANTIC, STATE OF NEW JERSEY, as follows:**

**Section 1.** Pursuant to the provisions of N.J.S.A. 40A:2-26(f), the bonds of the Township, authorized pursuant to the bond ordinances of the Township heretofore adopted and described in Section 2 hereof, shall be combined into a single issue of General Obligation Bonds, Series 2016 in the aggregate principal amount not exceeding \$5,225,000 to be issued in one or more separate series aggregating said amount and to memorialize the applicable obligations of the general or utility funds of the Township.

**Section 2.** The principal amount of bonds authorized by each ordinance to be combined into a single issue as above provided, the bond ordinances authorizing the Bonds described by reference to the ordinance number, description and date of final adoption, amount of issue and average period of usefulness determined in each of the bond ordinances are respectively as set forth in **Exhibit B** hereto.

**Section 3.** The following matters are hereby determined with respect to the combined issue of Bonds:

(a) The average period of usefulness, computed on the basis of the respective amounts of Bonds presently authorized to be issued pursuant to each of the bond ordinances and the respective periods or average periods of usefulness therein determined, is **10.621 years**.

(b) The Bonds of the combined issue shall be designated "**General Obligation Bonds, Series 2016**" (or such other designation if such Bonds are issued in two separate series to memorialize the applicable obligations of the general or utility funds of the Township) and shall mature within the average period of usefulness hereinabove determined.

(c) The Bonds of the combined issue shall be sold and issued in accordance with the provisions of the Local Bond Law that are applicable to the sale and issuance of bonds authorized by a single bond ordinance and accordingly may be sold with other issues of bonds.

**Section 4.** The following additional matters are hereby determined, declared, recited and stated:

(a) None of the Bonds described in Section 2 hereof have been sold or issued heretofore, and the several bond ordinances described in Section 2 have not been rescinded heretofore and now remain in full force and effect as authorizations for the respective amounts of bonds set opposite the descriptions of the bond ordinances set forth in Section 2 hereof.

(b) The several purposes or improvements authorized by the respective bond ordinances described in Section 2 hereof are purposes for which bonds may be issued lawfully pursuant to the Local Bond Law and some of such improvements or purposes, if applicable and permitted by law, a deduction may be taken in any annual or supplemental debt statement.

**Section 5.** In accordance with the provisions of N.J.S.A. 40A:2-27(a)(2), the Township hereby delegates to the Chief Financial Officer of the Township the power to sell and award the Township's not to exceed \$5,225,000 General Obligation Bonds, Series 2016 (collectively, the "Bonds") to the ACIA in accordance with the provisions hereof and in accordance with the terms of a Bond Purchase Agreement by and between the Township and the ACIA (the "Bond Purchase Agreement"). The Mayor of the Township (the "Mayor") or Chief Financial Officer of the Township (the "Chief Financial Officer") are each hereby authorized and directed on behalf of the Township, in consultation with Bond Counsel (as hereinafter defined), to negotiate the terms of such Bond Purchase Agreement, to be dated the date of sale of the Bonds, to approve the terms of the aforesaid Bond Purchase Agreement and to execute and deliver said Bond Purchase Agreement to the ACIA. The Bonds have been referred to and described in the Ordinances being finally adopted at duly called and held meetings of the Township Committee and published as required by law and which



Ordinances where combined for purposes of sale pursuant to this resolution, all pursuant to terms of the Local Bond Law and other applicable law.

**Section 6.** The Chief Financial Officer is hereby authorized and directed to determine, in accordance with the Local Bond Law and pursuant to the terms and conditions established by the ACIA and the terms and conditions hereof and set forth in the Bond Purchase Agreement, the following items with respect to the Bonds, except those terms and conditions which are set forth in the Bond Purchase Agreement:

- (a) The aggregate principal amount of the Bonds to be issued, provided that the total amount of Bonds issued shall not exceed the aggregate principal amount of \$5,225,000 (which may be issued in one series or two separate series aggregating said amount and to memorialize the applicable obligations of the general or utility funds of the Township);
- (b) The maturity and principal installments of the Bonds, which maturity shall not exceed 10 years;
- (c) The date of the Bonds;
- (d) The interest rates of the Bonds, which interest rate shall not exceed five percent (5%) per annum;
- (e) The purchase price of the Bonds; and
- (f) The terms and conditions under which the Bonds shall be subject to redemption prior to their stated maturities.

**Section 7.** Any determination made by the Chief Financial Officer pursuant to the terms hereof shall be conclusively evidenced by the execution and attestation of the Bonds by the parties authorized under Section 8(c) hereof.

**Section 8.** The Township Committee hereby determines that certain terms of the Bonds shall be as follows:

- (a) The Bonds shall be issued in a single denomination and shall be numbered GO-1 (or such other designation if such Bonds are issued in two separate series to memorialize the applicable obligations of the general or utility funds of the Township);
- (b) The Bonds shall be issued in fully registered form and shall be payable to the registered owners thereof as to both principal and interest in lawful money of the United States of America; and
- (c) The Bonds shall be executed by the manual or facsimile signatures of the Mayor and the Chief Financial Officer under official seal or facsimile thereof affixed, printed, engraved or reproduced thereon and attested by the manual signature of the Clerk of the Township (the "**Township Clerk**").

**Section 9.** The Bonds shall be substantially in the form set forth in **Exhibit A** attached hereto with such additions, deletions and omissions as may be necessary for the Township to comply with the requirements of the 2016 ACIA Pooled Loan Program, upon the advice of Bond Counsel.

**Section 10.** The law firm of Fleishman Daniels Law Offices, LLC, Linwood, New Jersey, Bond Counsel to the Township ("**Bond Counsel**"), the Township Engineer, the Township Attorney and the

Township Auditor are each hereby authorized and directed to perform all actions necessary to consummate the issuance of the Bonds and the Capital Improvement Projects for which the Bonds are issued, including but not limited to, drafting and arranging for the printing and execution of the Bonds and all applicable documentation necessary to memorialize and consummate the issuance of the Bonds and the undertaking of the Capital Improvement Projects, preparing all necessary financial information, all engineering and design work, preparation of plans and specifications and conducting all necessary studies, searches and analysis in connection with the issuance of the Bonds and the undertaking of the Capital Improvement Projects. The Mayor, the Chief Financial Officer, the Township Clerk, the Township Attorney and any other Township representative (including Bond Counsel or the Township Auditor) are each hereby authorized and directed to execute and deliver any certificates necessary or desirable in connection with the financial and other information.

**Section 11.** The Mayor, the Chief Financial Officer, the Township Clerk and any other Township representative, are each hereby authorized and directed to (i) execute any certificates or documents necessary or desirable in connection with the sale of the Bonds, including the Bond Purchase Agreement, or the undertaking of the Capital Improvement Projects, and each are hereby further authorized and directed to deliver same to the County and/or ACIA, as applicable, upon delivery of the Bonds and the applicable receipts of payment therefore, or in accordance with the 2016 ACIA Pooled Loan Program and (ii) perform such other actions as they deem necessary, desirable or convenient, in consultation with Bond Counsel, in relation to the execution and delivery thereof.

WHEREAS, N.J.S.A. 40A:12-13 (a) authorizes a municipality to sell by public sale at auction, real property which it determined is no longer necessary for public municipal purposes; and

WHEREAS, the properties listed in Exhibit A are no longer needed for any municipal purposes by the Township of Egg Harbor;
