Meeting with Township Engineer Mott

Generator Bids

Engineer Mott reported sealed bids were received and opened on November 13th for Community Center Generator Installation Rebid (report attached to minutes). A total of ten (10) bid packages were picked up and only three (3) contractors submitted bids. MJF Electrical Contracting of Treose, Pennsylvania was the lowest bidder, below his estimate and Engineer Mott recommended Township Committee consider awarding contract. A brief discussion followed regarding local contractors versus out of state contractors.

2015 Road Program

Engineer Mott advised committee that due to imminent rain tomorrow and a late start today, A.E. Stone plans on working on subbase paving on Alder Avenue until 10:00 p.m. tonight.

A brief discussion followed regarding traffic backup at the Zion and Bargaintown Road county intersection. Engineer Mott believes the timing of the light needs to be changed. Administrator Miller will contact John Peterson, Atlantic County Planner to discuss.

New Business

Street Vacation in Morris Beach

Administrator Miller showed the governing body Sheet 93 of the Township Tax Map with Hill Avenue, Jones Avenue and Wright Avenue highlighted. He explained that Ordinance 38 scheduled for introduction tonight will vacate what he has highlighted and basically dissolve the roads, consolidating them into the lot that is owned by the Township.

Left Turn Prohibition from Ravenworth Court

Administrator Miller explained that as part of county approvals for the Michael's project they had to prohibit left turn from Ravenworth Court onto Fire Road. He said our planning board did discuss said prohibition. Ordinance No. 34 scheduled for introduction tonight establishes the prohibition.

Budget Transfers

Administrator Miller said Resolution 460 scheduled for adoption this evening has been revised by \$2,000 since Friday and handed out a revised copy. He explained that every November and/or December it is necessary to make budget transfers. A brief discussion followed regarding the purchasing of an ambulance.

Flexible Spending Plan for Employees

Administrator Miller explained that for several years we have used AFLAC. Last year they charged us a fee and this year the fee increased. Administrator Miller found a company for a reduced fee.




