

INSTRUCTIONS, APPLICATION AND CHECKLIST FOR PEDDLERS

INSTRUCTIONS

PEDDLER [Any person, whether a resident of the Township or not, traveling by foot, cart, motor vehicle or any other type of conveyance, from place to place, from house to house or from street to street, carrying, conveying or transporting goods, merchandise, food or provisions, offering and exposing the same for sale or making sales and delivering articles to purchasers. Vendors are included.]

Pursuant to Chapter 129-2, it shall be unlawful for any person to engage in the business of a peddler within the corporate limits of the Township without first obtaining a license.

Pursuant to Chapter 129-3, the license fee for a peddler shall be \$75 per year.

Pursuant to Chapter 129-4, no peddler shall have an exclusive right to any location, nor shall he be permitted to operate in any congested area where his operations might impede or inconvenience the public. For the purpose of this article, the judgment of a police officer, exercised in good faith, shall be deemed conclusive as to whether the area is congested or the public impeded or inconvenienced. Additionally, No license or permit which includes use of a vehicle shall permit the licensee to sell from the same location on a public roadway to within the area of 100 feet from that location for a period of more than one hour.

Pursuant to Chapter 129-5, no person shall sell, offer for sale, hawk or peddle in the Township before 9:00 a.m. or after sundown.

Pursuant to Chapter 129-6, when a licensed activity is conducted at a fixed location or from a vehicle, the license shall be prominently displayed at the location or on the vehicle. In all other cases, the licensee shall have the license in his possession at all times and shall display it upon the request of any police officer or any person with whom he is doing business.

Pursuant to Chapter 129-7, exceptions to the application process are: (1) The delivery of newspapers or such other necessary merchandise of the type commonly delivered on a house-to-house basis at intervals of less than one week; and (2) Federal census takers and polls or surveys taken pursuant to federal, state or local laws.

In addition, any veteran or volunteer fireman who holds a special license issued pursuant to N.J.S.A. 45:24-9 shall be exempt from application for a license but shall be required to comply with all other applicable sections of this article.

Pursuant to Chapter 129-8, the equipment used or employed by peddlers of ice cream, food, beverages, confections and other related commodities shall be maintained in a clean and sanitary manner and be subject to the inspection of the Board of Health or its authorized agents. Any violation found and not immediately corrected shall be grounds for revocation of the license.
