EGG HARBOR TOWNSHIP – Egg Harbor Township has secured \$380,000.00 in grants administered through the New Jersey Department Community Affairs (NJDCA) as part of Phase II of the post Sandy Planning Grant Program. The grants will fund a comprehensive planning document to analyze risks the Township faces from future natural disasters, address various land uses concerns which have been identified, and ultimately increase resiliency for Township infrastructure and buildings.

There were numerous individual grants awarded which include:

The Township will be undertaking all work for the Phase 2 grants over the course of the next year with an anticipated completion of May of 2017. These grants follow the Township's work under Phase I of the program which resulted in the Township's Strategic Recovery Planning Report which was also funded by the NJDCA.
